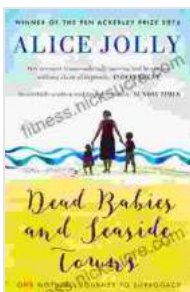


Dead Babies and Seaside Towns: A Tale of Murder, Obsession, and the Fragility of Innocence

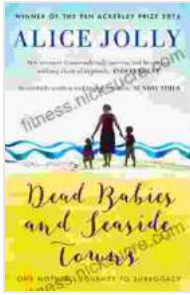

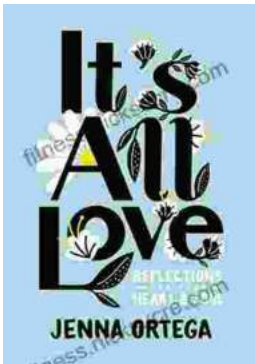
